Bylaw Notice Dispute Adjudication Registry Agreement Bylaw

**A Bylaw to authorize the Bylaw Notice Dispute/Adjudication Registry Agreement
Held between the Village of Burns Lake and the Regional District of Bulkley-Nechako**

The Council of the Village of Burns Lake in an open meeting assembled, hereby enacts as follows:

1. Citation:

This Bylaw may be cited for all purposes as the *“Corporation of the Village of Burns Lake Bylaw Notice Dispute Adjudication Registry Agreement Bylaw No. 1092, 2025”*

2. Bylaw Repealed:

Not applicable.

3. Purpose:

(a) WHEREAS per Section 2(4) of the Local Government Bylaw Notice Enforcement Act, which requires a bylaw where two or more Local Governments jointly conduct anything they are authorized to do under this Act;

AND WHEREAS the Corporation of the Village of Burns Lake and the Regional District of Bulkley Nechako (RDBN) are signees to a Bylaw Notice Dispute Adjudication Registry Agreement, which authorizes the RDBN to jointly operate a Bylaw Notice Dispute Adjudication Registry with and for the Village of Burns Lake;

AND WHEREAS that agreement falls under that which is jointly conducted under the *Local Government Bylaw Notice Enforcement Act*;

(b) NOW THEREFORE, Council for the Corporation of the Village of Burns Lake, in an open meeting assembled, ENACTS AS FOLLOWS:

4. The following definitions are hereby applied for the year 2023:

(a) “Act” means the Local Government Bylaw Notice Enforcement Act, S.B.C. 2003, c 60.

“Agreement” means the Regional District of Bulkley Nechako Bylaw Notice Dispute Adjudication Registry Agreement, 2025, between the Village of Burns Lake and the Regional District of Bulkley Nechako.

“Council” means the elected Council of the Corporation of the Village of Burns Lake.

“Parties” means the Regional District of Bulkley Nechako and the Corporation of the Village of Burns Lake.

Party” means any one of the Parties.

5. General Provisions:

The Council of the Village of Burns Lake hereby enacts the Agreement as required by Section 2(4) of the Local Government Bylaw Notice Enforcement Act. The Agreement is attached as Appendix 1 to this Bylaw.

6. Full Force and Effect:


This Bylaw has full force and effect from the date of adoption until amended, repealed, or replaced.
