BYLAW NO 1098, 2025

A Bylaw to Establish Fees and Charges for Village Services

Council for the Corporation of the Village of Burns Lake, in open meeting assembled, enacts as follows:

**1. CITATION**

This Bylaw may be cited for all purposes as the *“Corporation of the Village of Burns Lake Fees and Charges Bylaw No. 1098, 2025.”*

**2. BYLAW REPEALED**

The *“Corporation of the Village of Burns Lake Fees and Charges Bylaw No. 1070, 2024”* is hereby repealed.

**Definitions – Arena Fees**

For the purposes of this Schedule, the following terms have the meanings set out below:

**Standard Rate**

Applies to all regular bookings by individuals, community groups, and organizations that do not meet the criteria for the Discounted or Commercial rates. This is the base rate for general use of the facility, including recreational hockey, figure skating, and casual rentals.

**Discounted Rate**

Applies to youth-focused, local (located within Village of Burns Lake or RDBN Areas B & E) non-profit organizations and school groups whose activities are primarily developmental or recreational in nature. This rate supports community access and youth engagement by offering reduced fees during non-prime hours or for qualifying programs.

**Commercial Rate**

Applies to businesses, private enterprises, or individuals offering for-profit programs or services, including tournaments, events, or private rentals that involve an admission fee, participant fee, or revenue generation. This rate also applies to non-local organizations renting the facility for commercial purposes


