**THE CORPORATION OF THE VILLAGE OF BURNS LAKE**  
**AMENDMENT BYLAW NO. 901, 2009**

A bylaw to amend the "Corporation of the Village of Burns Lake Sewer Rates, Connections & Regulations By-Law #673, 1993".

**And**

"Corporation of the Village of Burns Lake Sewer Rates, Connections & Regulations By-Law #673, 1993, Amendment Bylaw #839".

**1. AMENDMENTS**

That the "Corporation of the Village of Burns Lake Sewer Rates, Connections & Regulations By-Law #673, 1993" be amended as follows:

- a) Section 1, c) shall read as:

If the Corporation disapproves of the connection, the owner shall be so informed and the reasons for its disapproval shall be given and the fee deposited accordingly to current Village of Burns Lake Fees and Charges Bylaw shall be forthwith repaid to the applicant.

- b) Section 1, d) shall read as:

Upon receipt of the application to connect the sewer and of the fee required under the current Village of Burns Lake Fees and Charges Bylaw hereof, the Corporation shall cause to be laid (unless already laid) a sewer connection extending from the common sewer to the applicant's property line. There upon, and previously, the owner shall connect his building sewer to the sewer connection provided, in accordance with the regulations hereinafter contained.

- c) Section 1, e) 1. shall read as:

The sewer connection fee deposited in accordance with the current Village of Burns Lake Fees and Charges Bylaw does not embrace works within the property of the applicant, except as to the inspection of the applicant's building sewer.

- d) Section 1, e) 2. shall read as:

No person, other than the Corporation, its employees or its contractors shall install or cause to be installed, any part of the sewer connection on public right-of-way, provided for under the current Village of Burns Lake Fees and Charges Bylaw, or in any way to break, interfere or tamper with any common sewer of the Corporation.

- e) Section 5, a) shall read as:

In addition to all other charges/ rates, rents, taxes and levies by any other bylaw of the Corporation imposed/ demanded, charged or levied there shall be paid to the Corporation of the Village of Burns Lake for the use of the Village sewerage system by the owner of each and every parcel of property connected to the Village sewer system, the rates as set out in the current Village of Burns Lake Fees and Charges Bylaw.

f) Schedule "B" shall be removed.

That the "Corporation of the Village of Burns Lake Sewer Rates, Connections & Regulations By-Law #673, 1993, Amendment Bylaw #839" be amended as follows.

a) Schedule "D" shall be removed.

**2. CITATION**


This Bylaw may be cited for all purposes as the "*Corporation of the Village of Burns Lake Sewer Rates, Connections & Regulations By-Law #673, 1993, Amendment Bylaw #839, Amendment Bylaw #901, 2009*".

READ A SECOND TIME this 10<sup>th</sup> day of March, 2009.

READ A THIRD TIME this 10<sup>th</sup> day of March, 2009.
